## INVITATION TO BID FOR THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED COMPLETION FOR THE CONSTRUCTION OF SPORTS COMPLEX AND RESIDENCES (PHASE 1C) FOR USTP-CDO

1. The University of Science and Technology of Southern Philippines (USTP), through the GOP for CY 2022 intends to apply the sum of **FIFTY MILLION PESOS AND 00/100 (P50,000,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for *Negotiated Procurement Under Two-Failed Biddings of the Proposed Completion for the Construction of Sports Complex and Residences (Phase 1C) for USTP-CDO (Contract No. USTP-IFPB-08-2022-1250-015)*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The USTP now invites bids for the above Procurement Project. Completion of the Works is required for *Four Hundred Eighty (480) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from USTP and inspect the Bidding Documents at the address given below from 8:00 – 12:00 NN and 1:00 - 5:00 PM weekdays.
5. A complete set of Bidding Documents may be acquired by interested bidders on **August 31, 2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWENTY-FIVE THOUSAND PESOS (P25,000.00) ONLY**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person or through electronic means*.
6. The USTP will hold a Pre-Bid Conference on **September 07, 2022, 10:00 A.M.** at Procurement Services, 2/F Gym Lobby, USTP CDO Campus, C.M. Recto Avenue, Cagayan de Oro City and/or through video conferencing or webcasting via Cisco WebEx, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **September 20, 2022, 09:30 A.M.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on **September 20, 2022, 10:00 A.M.** at the given address below and/or via Cisco WebEx. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The USTP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
