INVITATION TO BID FOR THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT FOR USTP-VILLANUEVA

1. The University of Science and Technology of Southern Philippines (USTP) CDO, through the IGI for CY 2021 intends to apply the sum of **ONE MILLION FIVE HUNDRED EIGHTY ONE THOUSAND ONE HUNDRED PESOS AND 00/100 (ABC: P1,581,100.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-Villanueva (Contract No. USTP-GSPB-07-2021-1277-013). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The USTP-CDO Campus now invites bids for the above Procurement Project. *Supply and Delivery* of the Goods is required by *Thirty (30) calendar days*. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from USTP-CDO and inspect the Bidding Documents at the address given below during 8:00 A.M. – 12:00 NN and 1:00 P.M. - 5:00 PM weekdays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **July 07, 2021** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of: **ONE THOUSAND FIVE HUNDRED PESOS AND 00/100 (P1,500.00) ONLY**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person or through electronic means*.
6. The USTP-CDO Campus will hold a Pre-Bid Conference on **July 14, 2021, 02:00 P.M.** at the Procurement Services, 2/F Gym Lobby, USTP CDO, C.M. Recto Avenue, Cagayan de Oro City, and/or through video conferencing or webcasting via Cisco Webex, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **July 26, 2021, 10:00 A.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **July 26, 2021, 10:00 A.M.** at the given address below and/or via Cisco Webex. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The USTP-CDO Campus reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
