INVITATION TO BID FOR THE PROPOSED CONSTRUCTION OF INNOVATION AND COLLABORATION HUB PHASE II, ALUBIJID (MAIN) CAMPUS CY 2026

1. The **University of Science and Technology of Southern Philippines – System (USTP-System)**, through the **GAA FY 2026** intends to apply the sum of **FIFTY MILLION PESOS AND 00/100 (P50,000,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract of the **Proposed Construction of Innovation and Collaboration Hub Phase II, Alubijid (Main) Campus CY 2026 (Contract No. USTP-IFPB04-08-2026-43-25769)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **USTP-System** now invites bids for the **Construction of Innovation and Collaboration Hub Phase II, Alubijid (Main) Campus CY 2026**. Completion of the Works is required within **Three Hundred Sixty-Five (365) calendar days**. Bidders should have completed, **within five (5) years** from the date of submission and receipt of bids, contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
3. Bidding will be conducted through competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the IRR, otherwise known as the “New Government Procurement Act (NGPA)”.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested Bidders may obtain further information from **USTP-System** and inspect the Bidding Documents at the address given below from **08:00 A.M. – 12:00 NN to 01:00 P.M. – 05:00 P.M. (Mondays to Fridays, except Holidays)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **AUGUST 06, 2026 (THURSDAY)** from the address given below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **TWENTY-FIVE THOUSAND PESOS AND 00/100 (P25,000.00) ONLY**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **USTP-System** will hold a Pre-Bid Conference on **AUGUST 13, 2026 (THURSDAY) @ 2:00 P.M.** at the **Conference Room, Procurement Services Section, 2nd Floor DRER Gymnasium, USTP-CDO Campus, C.M. Recto Avenue, Lapasan, Cagayan de Oro City** and/or through video conferencing via **Cisco Webex** which shall be open to prospective bidders: **Meeting number (access code): 2512 892 0918 | Meeting password: prebid2_AGILA**
7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the above-mentioned office address indicated below on or before **AUGUST 25, 2026 (TUESDAY), @ 01:30 P.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **AUGUST 25, 2026 (TUESDAY), @ 02:00 P.M.** at the above-mentioned address and/or via **Cisco Webex**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
10. Prospective bidders must be duly registered and classified by the **Philippine Contractors Accreditation Board (PCAB)** with a **License Category of at least Medium “A”** and **License Classification “B”**, valid at the time of bid submission. In compliance with **Sections 81.1 and 82 of the IRR of RA 12009**, bidders must submit a **Sworn Disclosure of Relations and Beneficial Ownership**. The disclosure must identify the **natural persons who ultimately own, control, or benefit from the bidding entity**, whether directly or indirectly.

The contract will be awarded to the bidder with the **Lowest Calculated and Responsive Bid (LCRB)**. Only bids that are **eligible, complete, and fully responsive** to the requirements of the Bidding Documents will be considered for award.

11. The **USTP-System** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 70 of RA No. 12009, without incurring any liability to the affected Bidder or Bidders.
