INVITATION TO BID FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF WAN DARK FIBER LEASE AND INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS CY 2026

1. The **University of Science and Technology of Southern Philippines – Cagayan de Oro (USTP-CDO) Campus**, through the **IGF FY 2026** intends to apply the sum of **FOUR MILLION THREE HUNDRED EIGHT THOUSAND PESOS AND 00/100 (P4,308,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Proposed Procurement of the Supply, Delivery, Installation and Commissioning of WAN Dark Fiber Lease and Internet Connectivity for USTP-CDO Campus CY 2026 (Contract No. USTP-GSPB05-06-2026-2241-26510)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **USTP-CDO Campus** now invites bids for **Supply, Delivery, Installation, and Commissioning of WAN Dark Fiber Lease and Internet Connectivity for USTP-CDO Campus CY 2026**. **Supply, Delivery, Installation and Commissioning** of the Goods is required **within Thirty (30) calendar days**. Bidders should have completed, **within three (3) years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested Bidders may obtain further information from **USTP-CDO Campus** and inspect the Bidding Documents at the address given below from **08:00 A.M. – 12:00 NN to 01:00 P.M. – 07:00 P.M. (Mondays to Thursdays, except Holidays)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **JUNE 19, 2026 (FRIDAY)** from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS AND 00/100 (P5,000.00) ONLY**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **USTP-CDO Campus** will hold a Pre-Bid Conference on **JUNE 29, 2026 (MONDAY), 10:00 A.M.** at the **Conference Room, Procurement Services Section, 2nd Floor DRER Gymnasium, USTP-CDO Campus, C.M. Recto Avenue, Lapanan, Cagayan de Oro City, and/or through video conferencing via Cisco Webex**, which shall be open to prospective bidders: **Meeting number (access code): 2517 708 5880 | Meeting password: prebid1_FIBER**.
7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through **manual submission at the above-mentioned office address indicated on or before JULY 13, 2026 (MONDAY), 09:30 A.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
9. Bid opening shall be on **JULY 13, 2026 (MONDAY), 10:00 A.M.** at the above-mentioned address and/or via **Cisco Webex**. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
10. **The contract will be awarded to the bidder with the Lowest Calculated and Responsive Bid (LCRB).**
11. The **USTP-CDO Campus** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 70 of RA No. 12009, without incurring any liability to the affected Bidder or Bidders.
