SUBJECT: AMENDMENTS IN THE BIDDING DOCUMENTS

PROJECT: PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF MEDICAL LABORATORY EQUIPMENT FOR THE COLLEGE OF MEDICINE CY 2023

This Bid Bulletin #01-GOODS-2023 is issued to modify or amend the requirement in the Bidding Documents. This shall form an integral part of the Bidding Process.

- i. The new applicable fees for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB are the following:

- ii. The Approved Budget for the Contract is changed from *THIRTY-SEVEN MILLION SEVEN HUNDRED EIGHTY-SEVEN THOUSAND PESOS AND 00/100 (P37,787,000.00)* to **THIRTY-SEVEN MILLION SEVEN HUNDRED EIGHTY-SIX THOUSAND NINE HUNDRED NINETY-NINE PESOS AND 98/100 (P37,786,999.98)**.
- iii. The contract duration is changed from *Sixty (60) calendar days* to **Ninety (90) calendar days** for all lots.
- iv. Per Instructions to Bidder Clause 5.3, "*for the procurement of Non-expendable Supplies and Services: The Bidder must have completed a **single contract** that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC.*" For this purpose, the ABC shall refer to the total budget allocated for the lot(s) bid by the bidder.
- v. In the Instructions to Bidder:

- vi. There are modifications/clarifications in the specifications particularly for **Item Nos. 2, 4 and 23**, as incorporated in the hereto attached **Revised Bid Form**.
- vii. The Deadline for Submission and Opening of Bids is moved from *May 24, 2023, 10:00 A.M.* to **May 29, 2023, 10:00 A.M.**
- viii. The rest of the Bidding Documents are modified accordingly.
