Notes on the Bid Data Sheet

The Bid Data Sheet (BDS) consists of provisions that supplement, amend, or specify in detail, information, or requirements included in the ITB found in Section II, which are specific to each procurement.

This Section is intended to assist the Procuring Entity in providing the specific information in relation to corresponding clauses in the ITB and has to be prepared for each specific procurement.

The Procuring Entity should specify in the BDS information and requirements specific to the circumstances of the Procuring Entity, the processing of the procurement, and the bid evaluation criteria that will apply to the Bids. In preparing the BDS, the following aspects should be checked:

- a. Information that specifies and complements provisions of the ITB must be incorporated.
- b. Amendments and/or supplements, if any, to provisions of the ITB as necessitated by the circumstances of the specific procurement, must also be incorporated.

19.3	<i>Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Cloud-Based Admission and Enrollment System.</i>
20.2	<p>Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law.</p> <p><i>NOTE: The latest income and business tax returns are those within the last six (6) months preceding the date of bid submission.</i></p>
21.2	<p><i>Additional Requirements:</i></p> <p><i>The technical specification that shall be submitted by the Bidder shall include, among others:</i></p> <ul style="list-style-type: none"> a. <i>offered product specifications as supported by brochures or catalogues;</i> b. <i>project management team for USTP Admission and Enrollment System;</i> c. <i>certification for the Software Perpetual License to USTP;</i> d. <i>certification for one (1) Year Warranty and Support;</i> e. <i>certification for Customization for one (1) Year; and</i> f. <i>affidavit of strict compliance to Data Privacy Act of 2012 and confidentiality.</i>
