Notes on the Special Conditions of Contract

Similar to the BDS, the clauses in this Section are intended to assist the Procuring Entity in providing contract-specific information in relation to corresponding clauses in the GCC found in Section IV.

The Special Conditions of Contract (SCC) complement the GCC, specifying contractual requirements linked to the special circumstances of the Procuring Entity, the Procuring Entity's country, the sector, and the Works procured. In preparing this Section, the following aspects should be checked:

- a. Information that complements provisions of the GCC must be incorporated.
- b. Amendments and/or supplements to provisions of the GCC as necessitated by the circumstances of the specific purchase, must also be incorporated.

However, no special condition which defeats or negates the general intent and purpose of the provisions of the GCC should be incorporated herein.

The Contractor shall submit the Program of Works to the Procuring Entity's Representative within seven (7) calendar days from receipt of the Notice to Award.
11.2	The amount to be withheld for the late submission of an updated Program of Work shall be fifteen percent (15%) of the total contract price.
13	The amount of the advance payment shall not exceed 15% of the total contract price and schedule of payment.
14	Materials and equipment delivered on the site but not completely put in place shall not be included for payment.
15.1	The operating and maintenance manuals are required when percentage of completion is Ninety percent (90%). "As built" drawings are required when percentage of completion is Ninety percent (90%).
