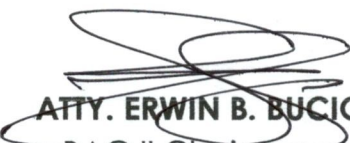

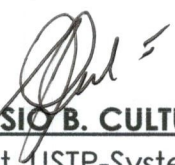

BAC RESOLUTION CBNO. 0095-2025

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT TO TRENCH ENGINEERING AND CONSTRUCTION SERVICES FOR THE PROPOSED CONSTRUCTION OF THE TWO (2) STOREY INFORMATION TECHNOLOGY AND COMMUNICATION HUB BUILDING AT USTP-PANAON CAMPUS (PHASE 2) CY 2025 IN THE AMOUNT OF P4,744,438.85

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Construction of the Two (2) Storey Information Technology and Communication Hub Building at USTP-Panaon Campus (Phase 2) CY 2025* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FIVE MILLION PESOS AND 00/100 (P5,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: Risan Construction (Risan), Trench Engineering and Construction Services (Trench) and L&L Construction (L&L);

WHEREAS, on the deadline for submission of bids last September 29, 2025, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Risan and L&L were rated "failed" due to the following ground: a) *The submitted SLCC was not supported by an Owner's Certificate of Final Acceptance issued by the project owner other than the contractor or a final rating of at least Satisfactory in the Constructors Performance Evaluation System (CPES) in accordance with 2016 Revised IRR of R.A. 9184 Section 23.4.2.5;*

WHEREAS, Trench was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee informed the representatives of Risan and L&L who were present during the bid opening that they may submit a request for reconsideration *within three (3) calendar days;*

WHEREAS, the Committee then opened the second envelope of Trench;

WHEREAS, Trench made a bid of P4,744,437.87;

WHEREAS, the Committee considered the bid of Trench for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated October 02, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the

TWG, last October 02, 2025, 02:00 P.M. on the bid of Trench. The Committee made an arithmetical correction in the financial bid of Trench, the amount of bid as read was not the same as calculated;

WHEREAS, in the Bid Form of Trench, there is a discrepancy in the total amount of bid. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3, "*In case of discrepancies between xxx (c) stated total price and the actual sum of prices of component items, the latter shall prevail*". Therefore, the total amount of bid is considered;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Trench to be complying and declared the bid of Trench as the Single Calculated Bid (SCB) at the amount of P4,744,438.85;

WHEREAS, the Committee conducted an onsite post-qualification of Trench at their new office in Tibasak, Macasandig, Cagayan De Oro City, Misamis Oriental last October 13, 2025;

WHEREAS, per Section 34.4 of the Revised IRR of R.A. 9184 provides that "*If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.*" The Committee determined the amount of award at P4,744,438.85;

WHEREAS, the Committee requested Trench to submit a corrected Bid Form (Bill of Quantities) and Detailed Estimates, in accordance with DPWH D.O. No. 197, series of 2016, and Section 34.4 of the Revised IRR of R.A. 9184. Trench was able to submit the required documents;

WHEREAS, the Committee convened and deliberated the results of their Post-Qualification on October 14, 2025. It was found that all the documents submitted by Mr. Roald Y. Dy of Trench were genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Trench Engineering and Construction Services* as the Single Calculated and Responsive Bid (SCRB) for *Proposed Construction of the Two (2) Storey Information Technology and Communication Hub Building at USTP-Panaon Campus (Phase 2) CY 2025*; and
- b) recommend the award of the contract in the total amount of **FOUR MILLION SEVEN HUNDRED FORTY-FOUR THOUSAND FOUR HUNDRED THIRTY-EIGHT PESOS AND 85/100 (P4,744,438.85) ONLY.**

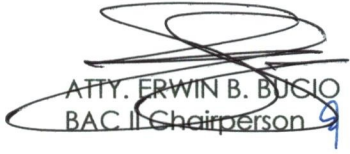
