BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO TESTLAB ENGINEERING AND GEOTECH SERVICES FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF CIVIL ENGINEERING LABORATORY EQUIPMENT FOR USTP-ALUBIJID CAMPUS CY 2025 IN THE AMOUNT OF P4,391,209.69

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Civil Engineering Laboratory Equipment for USTP-Alubijid Campus CY 2025 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FOUR MILLION NINE HUNDRED EIGHTY-ONE THOUSAND EIGHT HUNDRED PESOS AND 00/100 (P4,981,800.00) ONLY;* 

**WHEREAS**, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Prexiphil Corporation (Prexiphil) and TestLab Engineering and Geotech Services (TestLab);

**WHEREAS**, on the deadline for submission of bids last August 07, 2025, 01:30 P.M., only TestLab submitted its bid proposal. Prexiphil did not submit any bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, TestLab was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of TestLab;

WHEREAS, TestLab made a bid of P4,391,239.69;

WHEREAS, the Committee considered the bid of TestLab for evaluation;

**WHEREAS,** the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated August 14, 2025;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last August 14, 2025, 03:00 P.M. on the bid of TestLab. The Committee made an arithmetical correction in the financial bid of TestLab, the amount of bid as read was not the same as calculated;

**WHEREAS**, in the Bid Form of TestLab, there is a discrepancy in the total amount of bid. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3, "In case of discrepancies between xxx "(c) stated total price and the actual sum of prices of component items, the latter shall prevail". Therefore, the total amount of bid is considered;
