BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PARASAT CABLE TV, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS CY 2025 IN THE AMOUNT OF P1,200,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Internet Connectivity for USTP-CDO Campus CY 2025* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED THOUSAND PESOS AND 00/100 (P1,200,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Parasat Cable TV, Inc. (Parasat);

WHEREAS, on the deadline for submission of bids last September 15, 2025, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Parasat was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Parasat;

WHEREAS, Parasat made a bid of P1,200,000.00;

WHEREAS, the Committee considered the bid of Parasat for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated September 16, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last September 16, 2025, 03:00 P.M. on the bid of Parasat. The Committee made no arithmetical correction in the financial bid of Parasat, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Parasat to be complying and declare the bid of Parasat as the Single Calculated Bid (SCB) at the amount of P1,200,000.00;

WHEREAS, the Committee conducted an on-site post-qualification of Parasat at their branch office in Rosario Arcade, Limketkai Center, Cagayan de Oro City last September 19, 2025;

WHEREAS, the Committee convened and deliberated the results of their Post-Qualification on September 23, 2025. It was found that all the documents submitted by Mr. Herbie Paul E. Razalo of




Parasat were genuine, authentic and responsive;
