#### BAC RESOLUTION CBNO. 0096-2025

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO INFINIVAN, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ADDITIONAL 500MBPS INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS CY 2025 IN THE AMOUNT OF P742,010.52

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Additional 500Mbps Internet Connectivity for USTP-CDO Campus CY 2025 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION FOUR HUNDRED THOUSAND NINETEEN PESOS AND 96/100 (P1,400,019.96) ONLY;

WHEREAS, in response to the said advertisement, six (6) prospective bidders acquired the bidding documents, namely: Multifactors Sales (Multifactors), DCTech Micro Services, Inc. (DCTech), PLDT, Inc. (PLDT), Converge Information & Communications Technology Solutions, Inc. (Converge), InfiniVAN, Inc. (InfiniVAN) and Parasat Cable TV, Inc. (Parasat);

WHEREAS, on the deadline for submission of bids last September 30, 2025, 01:30 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, PLDT, Converge, InfiniVAN, Parasat and Multifactors were rated "passed" in the preliminary examination of their legal, technical and financial;

WHEREAS, DCTech was rated "failed" in the preliminary examination of its legal, technical and financial documents due to the following ground: a) The submitted Single Largest Completed Contract (SLCC) did not comply with Bid Data Sheet ITB Clause 5.3b;

WHEREAS, the Committee then opened the second envelopes of PLDT, Converge, InfiniVAN, Parasat and Multifactors;

WHEREAS, PLDT made a bid of P885,792.00;

WHEREAS, Converge made a bid of P813,984.00;

WHEREAS. InfiniVAN made a bid of P742.010.52:

WHEREAS, Parasat made a bid of P840,011.98;

WHEREAS, Multifactors was rated "failed" in its financial component due to the following ground: a) The submitted Bid Form duly signed by BAC Chairperson was not signed by an authorized representative;

**WHEREAS**, the Committee informed the representatives of DCTech and Multifactors who were present during the bid opening that they may submit a request for reconsideration within three (3) calendar days;

**WHEREAS**, the Committee considered the bids of PLDT, Converge, InfiniVAN and Parasat for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated October 03, 2025;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last October 03, 2025, 10:00 A.M. on the bids of PLDT, Converge, InfiniVAN and Parasat. The Committee made no arithmetical correction in the financial bids of PLDT, Converge and InfiniVAN, the amount of bid as read were the same as calculated. However, the Committee made an arithmetical correction in the financial bid of Parasat, the amount of bid as read was not the same as calculated:

**WHEREAS**, in the Bid Form of Parasat, there is a discrepancy in the total amount of bid. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3, "In case of discrepancies between xxx "(c) stated total price and the actual sum of prices of component items, the latter shall prevail". Therefore, the total amount of bid of Parasat is considered;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of PLDT, Converge, InfiniVAN and Parasat to be complying and declare the bid of InfiniVAN as the Lowest Calculated Bid (LCB) at the amount of P742,010.52;

WHEREAS, DCTech and Multifactors did not submit a request for reconsideration;

**WHEREAS**, the Committee conducted an on-site post-qualification of InfiniVAN at their main office in 17<sup>th</sup> Floor, Ore Central Tower, 9<sup>th</sup> Avenue, Corner 31<sup>st</sup> Street, Bonifacio Global City, Fort Bonifacio, Taguig City last October 13 – 14, 2025;

**WHEREAS**, the Committee convened and deliberated the results of their Post-Qualification on October 15, 2025. It was found that all the documents submitted by Ms. Seirril Anne S. Oblea of InfiniVAN were genuine, authentic and responsive;

**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of InfiniVAN, Inc. as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Additional 500Mbps Internet Connectivity for USTP-CDO Campus CY 2025; and
- b) recommend the award of the contract to the said bidder in the total amount of **SEVEN HUNDRED FORTY-TWO THOUSAND TEN PESOS AND 52/100 (P742,010.52) ONLY.**
