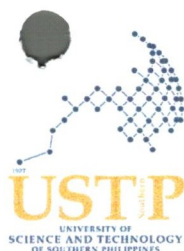

BAC RESOLUTION CBNO. 0104-2025

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO INFINIVAN, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF REDUNDANCY LINE 3GBPS INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS CY 2025 IN THE AMOUNT OF P3,111,120.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Redundancy Line 3Gbps Internet Connectivity for USTP-CDO Campus CY 2025* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of THREE MILLION SIX HUNDRED THOUSAND PESOS AND 00/100 (P3,600,000.00) ONLY;

WHEREAS, in response to the said advertisement, four (4) prospective bidders acquired the bidding documents, namely: InfiniVAN, Inc. (InfiniVAN), DCTech Micro Services, Inc. (DCTech), Converge Information & Communications Technology Solutions, Inc. (Converge) and Parasat Cable TV, Inc. (Parasat);

WHEREAS, on the deadline for submission of bids last October 13, 2025, 09:30 A.M., only InfiniVAN, Converge and Parasat submitted their bid proposals. DCTech's bid proposal was not accepted for having been submitted beyond the deadline for submission of bids;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, InfiniVAN, Converge and Parasat were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of InfiniVAN, Converge and Parasat;

WHEREAS, InfiniVAN made a bid of P3,111,120.00;

WHEREAS, Converge was rated "failed" in the second envelope due to the following ground: a) *The submitted Bid Form duly signed by BAC Chairperson was not signed by an authorized representative of the bidder;*

WHEREAS, Parasat made a bid of P1,809,200.00;

WHEREAS, the Committee informed the representative of Converge who was present during the bid opening that they may submit a request for reconsideration *within three (3) calendar days;*

WHEREAS, the Committee considered the bids of InfiniVAN and Parasat for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated October 16, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last October 16, 2025, 02:00 P.M. on the bids of InfiniVAN and Parasat. The Committee made no arithmetical correction in the financial bid of InfiniVAN, the amount of bid as read was the same as calculated. However, the Committee made an arithmetical correction in the financial bid of Parasat, the amount of bid as read was not the same as calculated;

WHEREAS, in the Bid Form of Parasat, there is a discrepancy in the total amount of bid. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3, "In case of discrepancies between xxx "(c) stated total price and the actual sum of prices of component items, the latter shall prevail". Therefore, the total amount of bid of Parasat is considered at P1,809,200.04;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of InfiniVAN and Parasat to be complying, and declared the bid of Parasat as the Lowest Calculated Bid (LCB);

WHEREAS, the Committee conducted an on-site post-qualification of Parasat on the eligibility, technical and financial documents starting October 23, 2025. However, upon careful examination, verification, validation and ascertainment of all statements and representations made, including all documents submitted, in relation to the bid proposal submitted by Parasat, the Committee found that its bid failed to comply with, and be responsive to, the requirements and conditions specified in the Bidding Documents for the said project, based on the following ground: *The Committee found that the Statement of Ongoing Contract is incomplete because there are four (4) ongoing contracts that Parasat has with the USTP that were not included therein, including a contract that was awarded but not yet started. All of these on-going contracts pre-date the submission of the statement on October 13, 2025;*

WHEREAS, the Committee informed Parasat through Notice of Post-Disqualification dated October 28, 2025 in which the bidder was declared post-disqualified and advised that they may submit a letter-request for reconsideration within *three (3) calendar days* upon receipt. The notice was sent on October 28, 2025;

WHEREAS, Parasat submitted a request for reconsideration in a letter dated November 01, 2025 and received November 03, 2025, which the Committee denied in BAC Resolution CBN0. 0102-2025 dated November 04, 2025, and sent to Parasat on November 04, 2025;

WHEREAS, the Committee conducted an online post-qualification of InfiniVAN at their main office in 17th Floor, Ore Central Tower, 9th Avenue, Corner 31st Street, Bonifacio Global City, Fort Bonifacio, Taguig City last November 11, 2025;

WHEREAS, the Committee convened and deliberated the results of their Post-Qualification on November 12 and 25, 2025. It was found that all the documents submitted by Ms. Seiril Anne S. Oblea of InfiniVAN were genuine, authentic and responsive;

WHEREAS, the Post-Qualification activities had to be extended for sixteen (16) days beyond the 12-day period on account of: *a) further verification, ascertainment and deliberation and b) due to the Typhoons Tino and Uwan;*

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post-qualification activities, that is, on November 10 – 25, 2025 as per Section 34.8 of the Revised IRR of R.A. No. 9184;
- b) declare the bid of *InfiniVAN, Inc.* as the Lowest Calculated and Responsive Bid (LCRB) for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Redundancy Line 3Gbps Internet Connectivity for USTP-CDO Campus CY 2025*; and
