**BAC RESOLUTION NO. 0846-2024**

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO COLUMBIA COMPUTER CENTER, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF ICT EQUIPMENT FOR USTP-VILLANUEVA CAMPUS CY 2025 IN THE AMOUNT OF P2,315,160.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of ICT Equipment for USTP-Villanueva Campus CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FIVE HUNDRED SEVENTY THOUSAND FOUR HUNDRED PESOS AND 00/100 (P2,570,400.00) ONLY;

**WHEREAS**, in response to the said advertisement, four (4) prospective bidders acquired the bidding documents, namely: Columbia Computer Center, Inc. – Cagayan De Oro (Columbia), Solidmark, Inc. (Solidmark), Masangkay Computer Center (Masangkay) and Microtrade GCM Corporation (Microtrade);

**WHEREAS**, on the deadline for submission of bids last December 16, 2024, 09:30 A.M., the same prospective bidders submitted their bid proposals;

**WHEREAS**, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

**WHEREAS**, Columbia, Masangkay and Solidmark were rated "passed" in the preliminary examination of their legal, technical and financial documents;

**WHEREAS**, Microtrade was rated "failed" due to the following ground: a) *The submitted Bid Securing Declaration is not updated;*

**WHEREAS**, the Committee informed the representative of Microtrade who was present during the bid opening that they may submit a request for reconsideration *within three (3) calendar days;*

**WHEREAS**, the Committee then opened the second envelopes of Columbia, Masangkay and Solidmark;

**WHEREAS**, Columbia made a bid of P2,315,160.00;

**WHEREAS**, Masangkay made a bid of P2,323,656.00;

**WHEREAS**, Solidmark made a bid of P2,332,512.00;

**WHEREAS**, the Committee considered the bids of Columbia, Masangkay and Solidmark for evaluation;

**WHEREAS**, Microtrade did not submit any request for reconsideration;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated December 19, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last December 19, 2024, 02:00 P.M. on the bids of Columbia, Masangkay and Solidmark. The Committee made no arithmetical corrections in the financial bids of Columbia, Masangkay and Solidmark, the amount of bids as read were the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Columbia, Masangkay and Solidmark to be complying and declared the bid of Columbia as the Lowest Calculated Bid (LCB) at the amount of P2,315,160.00;

**WHEREAS**, the Committee conducted an online post-qualification of Columbia at their main office in T. Neri St., Cagayan de Oro City, Misamis Oriental on December 21, 2024;


**WHEREAS**, the Committee convened and deliberated the results of their Post-Qualification on the same day. It was found that all the documents submitted by Mr. Renante E. Elpa of Columbia were genuine, authentic and responsive;


**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Columbia Computer Center, Inc.* as the Lowest Calculated and Responsive Bid (LCRB) for the *Proposed Procurement of the Supply and Delivery of ICT Equipment for USTP-Villanueva Campus CY 2025*; and
- b) recommend the award of the contract in the total amount of **TWO MILLION THREE HUNDRED FIFTEEN THOUSAND ONE HUNDRED SIXTY PESOS AND 00/100 (P2,315,160.00) ONLY.**


