BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO NEWBITECH IT SOLUTIONS FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF HYPER-CONVERGED INFRASTRUCTURE SERVER FOR DIGITAL TRANSFORMATION OFFICE CY 2024 IN THE AMOUNT OF P5,600,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Hyper-Converged Infrastructure Server for Digital Transformation Office CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of SIX MILLION PESOS AND 00/100 (P6,000,000.00) ONLY:

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Newbitech IT Solutions (Newbitech);

WHEREAS, on the deadline for submission of bids last June 18, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Newbitech was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Newbitech;

WHEREAS, Newbitech made a bid of P5,600,000.00;

WHEREAS, the Committee considered the bid of Newbitech for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated June 25, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, on June 25, 2024, 02:00 P.M. on the bid of Newbitech. The Committee made no arithmetical correction in the financial bid of Newbitech, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Newbitech to be complying and declared the bid of Newbitech as the Single Calculated Bid (SCB) at the amount of P5,600,000.00;

WHEREAS, the Committee conducted an on-site post-qualification of Newbitech at their main office in 249A San Francisco Street, Brgy. Buhangin, Davao City last July 05 – 06, 2024;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on July 08, 2024. It was found that all the documents submitted by Mr. Warren C. Badong of Newbitech were

WHEREAS, the Post-Qualification activities had to be extended for one (1) day beyond the 12-day period on account of the delay of the confirmation of the Ongoing Projects of Newbitech;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post-qualification activities, that is, on July 08, 2024 as per Section 34.8 of the Revised IRR of R.A. No. 9184;
- b) declare the bid of *Newbitech IT Solutions* as the Single Calculated and Responsive Bid (SCRB) for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Hyper-Converged Infrastructure Server for Digital Transformation Office CY 2024*; and
- c) recommend the award of the contract in the total amount of **FIVE MILLION SIX HUNDRED THOUSAND PESOS AND 00/100 (P5,600,000.00) ONLY**.
