

#### **BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO DIGITAL MANUFACTURING SOLUTIONS, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF LABORATORY EQUIPMENT FOR ESTABLISHMENT OF FABRICATION LABORATORY OF USTP-JASAAN CAMPUS CY 2024 IN THE AMOUNT OF P3,680,000.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Laboratory Equipment for Establishment of Fabrication Laboratory of USTP-Jasaan Campus CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of THREE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS AND 00/100 (P3,680,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Digital Manufacturing Solutions, Inc. (DMS);

**WHEREAS**, on the deadline for submission of bids last July 30, 2024, 01:30 P.M., the same prospective bidder submitted its bid proposal;

**WHEREAS**, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, DMS was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of DMS;

**WHEREAS**, DMS made a bid of P3,680,000.00;

**WHEREAS**, the Committee considered the bid of DMS for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated August 06, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last August 06, 2024, 02:00 P.M. on the bid of DMS. The Committee made no arithmetical correction in the financial bid of DMS, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of DMS to be complying and declared the bid of DMS as the Single Calculated Bid (SCB) at the amount of P3,680,000.00;

**WHEREAS**, the Committee conducted an on-site post-qualification of DMS at their main office located in 131 Mezzanine Floor 7th Avenue, Caloocan City, Metro Manila last August 14 – 15, 2024;

**RESOLVED** this 19<sup>th</sup> day of August, 2024 at University of Science and Technology of Southern Philippines, Cagayan de Oro City.


