WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Electro-Mechanical Technology (EMT) Laboratory Equipment for USTP-Villanueva Campus CY 2024 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FIVE MILLION EIGHT HUNDRED THIRTEEN THOUSAND SIX HUNDRED FIFTY-TWO PESOS AND 42/100 (P5,813,652.42) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Hexatronics Marketing (Hexatronics);

**WHEREAS**, on the deadline for submission of bids last August 05, 2024, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, Hexatronics was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelope of Hexatronics;

WHEREAS, Hexatronics made a bid of P5,800,000.00;

WHEREAS, the Committee considered the bid of Hexatronics for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated August 08, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last August 08, 2024, 03:30 P.M. on the bid of Hexatronics. The Committee made no arithmetical correction in the financial bid of Hexatronics, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Hexatronics to be complying and declared the bid of Hexatronics as the Single Calculated Bid (SCB) at the amount of P5,800,000.00;

**WHEREAS**, the Committee conducted an on-site post-qualification of Hexatronics at their main office in Unit 4, 3rd Floor, The Prime Building MacArthur Highway, Brgy. San Sebastian, Tarlac City last August 14 – 15, 2024;
