BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PG MARKETING OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES AND MATERIALS FOR USTP-CDO CAMPUS CY 2024 IN THE AMOUNT OF P1,121,515.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Procurement of the Supply and Delivery of Janitorial Supplies and Materials for USTP-CDO Campus CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED FORTY-NINE THOUSAND NINE HUNDRED NINETY-NINE PESOS AND 70/100 (P1,249,999.70) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: PG Marketing;

**WHEREAS**, on the deadline for submission of bids last August 12, 2024, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, PG Marketing was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of PG Marketing;

WHEREAS, PG Marketing made a bid of P1,121,515.00;

WHEREAS, the Committee considered the bid of PG Marketing for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated August 19, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last August 19, 2024, 11:00 A.M. on the bid of PG Marketing. The Committee made no arithmetical correction in the financial bid of PG Marketing, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of PG Marketing to be complying and declared the bid of PG Marketing as the Single Calculated Bid (SCB) at the amount of P1,121,515.00;

**WHEREAS**, the Committee conducted an online post-qualification of PG Marketing at their main office in Cebu Street, Aluba Subdivision Phase 1, Barangay Macasandig, Cagayan De Oro City last August 29, 2024;
