BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO PENTAGON UNLIMITED TECHNOLOGIES, INC. IN THE AMOUNT OF P2,595,200.00 FOR LOT 1, DECLARING PARTIAL FAILURE OF BIDDING AND RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) FOR LOT 2 FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LABORATORY EQUIPMENT FOR BSIT AND BTLED OF USTP-PANAON CAMPUS CY 2025

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Laboratory Equipment for BSIT and BTLED of USTP-Panaon Campus CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION EIGHT HUNDRED THOUSAND PESOS AND 00/100 (P2,800,000.00) ONLY: LOT 1 – BSIT Laboratory Equipment (P2,600,000.00) & LOT 2 – BTLED Laboratory Equipment (P200,000.00);

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Pentagon Unlimited Technologies, Inc. (Pentagon);

**WHEREAS**, on the deadline for submission of bids last December 03, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder:

**WHEREAS**, Pentagon was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Pentagon;

WHEREAS, Pentagon made a bid of P2,595,200.00 for Lot 1;

WHEREAS, the Committee considered the bid of Pentagon for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated December 05, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last December 05, 2024, 02:30 P.M. on the bid of Pentagon. The Committee made no arithmetical correction in the financial bid of Pentagon, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Pentagon to be complying and declared the bid of Pentagon as the Single Calculated Bid (SCB) at the amount of P2,595,200.00 for Lot 1;

**WHEREAS**, the Committee conducted an on-site post-qualification of Pentagon at their main office in G/F ICT Business Center Bldg., Macahambus St., Barangay 14 Cagayan De Oro City, Misamis Oriental last December 13, 2024;

**WHEREAS**, the Committee convened and deliberated the results of their Post-Qualification on December 18, 2024. It was found that all the documents submitted by Mr. Raymond C. Fernando of Pentagon were genuine, authentic and responsive;

WHEREAS, in this case, there is no other prospective bidder for Lot 2:

WHEREAS, the Post-Qualification activities had to be extended for one (1) day beyond the 12-day period on account of the delay of the confirmation for the authenticity of the documents attached to the Single Largest Completed Contract (SLCC) of Pentagon;

**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post-qualification activities, that is, on December 18, 2024, as per Section 34.8 of the Revised IRR of R.A. No. 9184;
- b) declare the bid of Pentagon Unlimited Technologies, Inc. as the Single Calculated and Responsive Bid (SCRB) for Lot 1 of the Proposed Procurement of the Supply and Delivery of Laboratory Equipment for BSIT and BTLED of USTP-Panaon Campus CY 2025;
- c) recommend the award of the contract to the said bidder in the total amount of TWO MILLION FIVE HUNDRED NINETY-FIVE THOUSAND TWO HUNDRED PESOS AND 00/100 (P2,595,200.00) ONLY for LOT 1;
- d) declare failure of bidding for Lot 2; and
- e) recommend Negotiated Procurement-Small Value Procurement (NP-SVP) for Lot 2 with a total budget of **TWO HUNDRED THOUSAND PESOS AND 00/100 (P200,000.00) ONLY**.
