## **BAC RESOLUTION NO. 0997-2023**

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO MASANGKAY COMPUTER CENTER FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF COMPUTER WORKSTATIONS FOR COLLEGE OF INFORMATION TECHNOLOGY AND COMPUTING CY 2024 IN THE AMOUNT OF P3,074,508.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Computer Workstations for College of Information Technology and Computing CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of THREE MILLION TWO HUNDRED FORTY THOUSAND FOUR HUNDRED NINETY-TWO PESOS AND 00/100 (P3,240,492.00) ONLY;

**WHEREAS**, in response to the said advertisement, four (4) prospective bidders acquired the bidding documents, namely: Hawk Rescue Equipment and General Merchandise (Hawk Rescue), Xitrix Computer Corporation (Xitrix), Pentagon Unlimited Technologies, Inc. (Pentagon) and Masangkay Computer Center (Masangkay);

**WHEREAS**, on the deadline for submission of bids last December 12, 2023, 01:30 P.M., the same prospective bidders submitted their bid proposals;

**WHEREAS**, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

**WHEREAS**, Xitrix, Pentagon, Masangkay and Hawk Rescue were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of Xitrix, Pentagon, Masangkay and Hawk Rescue:

WHEREAS, Xitrix made a bid of P3,107,800.00;

WHEREAS, Pentagon made a bid of P3,209,480.00;

WHEREAS, Masangkay made a bid of P3,074,508.00;

WHEREAS, Hawk Rescue made a bid of P3,239,000.00;

**WHEREAS**, the Committee considered the bids of Xitrix, Pentagon, Masangkay and Hawk Rescue for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated December 14, 2023;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last December 14, 2023, 03:30 P.M. on the bids of Xitrix, Pentagon, Masangkay and Hawk Rescue. The Committee made no arithmetical correction in the financial bids of Xitrix, Pentagon, Masangkay and Hawk Rescue, the amount of bid as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Xitrix, Pentagon, Masangkay and Hawk Rescue to be complying and

declared the bid of Masangkay as the Lowest Calculated Bid (LCB) at the amount of P3,074,508.00;

**WHEREAS**, the Committee conducted an online post-qualification of Masangkay at their branch office in 1143G Masangkay St., Sta. Cruz, Manila, Metro Manila on December 20, 2023;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Peter W. Ko of Masangkay were genuine, authentic and responsive;

**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of Masangkay Computer Center as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Procurement of the Supply and Delivery of Computer Workstations for College of Information Technology and Computing CY 2024; and
- b) recommend the award of the contract in the total amount of **THREE MILLION SEVENTY-FOUR THOUSAND FIVE HUNDRED EIGHT PESOS AND 00/100 (P3,074,508.00) ONLY**.
