BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO SERV ENTERPRISES FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-OROQUIETA CAMPUS CY 2024 IN THE AMOUNT OF P976,025.00

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Library Books for USTP-Oroquieta Campus CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED EIGHT PESOS AND 00/100 (P999,908.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: SERV Enterprises (SERV);

**WHEREAS**, on the deadline for submission of bids last October 29, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, SERV was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelope of SERV:

WHEREAS, SERV made a bid of P976,025.00:

WHEREAS, the Committee considered the bid of SERV for evaluation:

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated October 31, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last October 31, 2024, 10:00 A.M. on the bid of SERV. The Committee made no arithmetical correction in the financial bid of SERV, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of SERV to be complying and declared the bid of SERV as the Single Calculated Bid (SCB) at the amount of P976,025.00;

**WHEREAS**, the Committee conducted an on-site post-qualification of SERV at their main office in 53A Saint James St., Maries Village II Phase 2, Mayamot, Antipolo City last November 07, 2024;
