BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO ASPEN MULTI-SYSTEM CORPORATION FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING FOR SKILLS LABORATORY AND CLASSROOM EQUIPMENT FOR COLLEGE OF MEDICINE CY 2024 IN THE AMOUNT OF P39,898,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning for Skills Laboratory and Classroom Equipment for College of Medicine CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FORTY MILLION PESOS AND 00/100 (P40,000,000.00) ONLY: Lot 1 – Skills Laboratory (P24,230,000.00) & Lot 2 – Virtual Dissection Table (P15,770,000.00);

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Aspen Multi-System Corporation (Aspen);

WHEREAS, on the deadline for submission of bids last June 06, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Aspen was rated “passed” in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Aspen;

WHEREAS, Aspen made a bid of P39,898,000.00 (Lot 1 – P24,148,000.00 & Lot 2 – P15,750,000.00);

WHEREAS, the Committee considered the bid of Aspen for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated June 10, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last June 10, 2024, 02:00 P.M. on the bid of Aspen. The Committee made no arithmetical correction in the financial bid of Aspen, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Aspen to be complying and declared the bid of Aspen as the Single Calculated Bid (SCB) at the amount of P39,898,000.00;

WHEREAS, the Committee conducted an on-site post-qualification of Aspen at their branch office located in Averilla St., Sta. Lucia, San Juan City, Metro Manila last June 20, 2024;
