BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO SCIGATE TECHNOLOGY, CORP. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF ADDITIONAL LABORATORY SUPPLIES FOR COLLEGE OF MEDICINE CY 2024 IN THE AMOUNT OF P838,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Additional Laboratory Supplies for College of Medicine CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION THREE HUNDRED FORTY-THREE THOUSAND PESOS AND 00/100 (P1,343,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: SciGate Technology, Corp. (SciGate);

WHEREAS, on the deadline for submission of bids last June 24, 2024, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, SciGate was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of SciGate;

WHEREAS, SciGate made a bid of P838,000.00;

WHEREAS, the Committee considered the bid of SciGate for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated June 26, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, on June 26, 2024, 10:00 A.M. on the bid of SciGate. The Committee made no arithmetical correction in the financial bid of SciGate, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of SciGate to be complying and declared the bid of SciGate as the Single Calculated Bid (SCB) at the amount of P838,000.00;

WHEREAS, the Committee conducted an online post-qualification of SciGate Technology, Corp. (SciGate) at their main office in N. Domingo Street, San Juan City, Metro Manila last July 02, 2024;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on July 08, 2024. It was found that all the documents submitted by Mr. Francisco L. Go. Jr. of SciGate were


