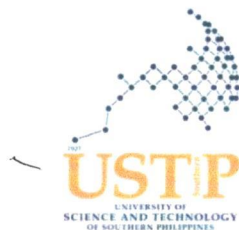

BAC RESOLUTION NO. 0797-2024

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PLDT, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ADDITIONAL INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS WIFI SERVICES CY 2024 IN THE AMOUNT OF P1,646,400.00 FOR ITEM NO. 1

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Additional Internet Connectivity for USTP-CDO Campus WIFI Services CY 2024 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION EIGHT HUNDRED FORTY-NINE THOUSAND NINE HUNDRED PESOS AND 04/100 (P2,849,900.04) ONLY: ITEM NO. 1 – INTERNET CONNECTION BANDWIDTH 1GBPS (P1,649,900.04) & ITEM NO. 2 – INTERNET CONNECTION BANDWIDTH 500MBPS (P1,200,000.00);

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: Converge Information & Communications Technology Solutions, Inc. (Converge), Parasat Cable Tv, Inc. (Parasat) and PLDT, Inc. (PLDT);

WHEREAS, on the deadline for submission of bids last November 12, 2024, 01:30 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Converge and PLDT were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, Parasat was rated "failed" in the preliminary examination of its legal, technical and financial documents due to the following grounds: a) the submitted Technical Specifications was not signed by the Bidder/Authorized Representative and b) non-submission of a duly accomplished Schedule of Requirements;

WHEREAS, the Committee informed the representatives of Parasat who were present during the bid opening that they may submit a request for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelopes of Converge and PLDT;

WHEREAS, Converge made a bid of P876,584.00 for Item No. 2;

WHEREAS, PLDT made a bid of P1,646,400.00 for Item No. 1;

WHEREAS, the Committee considered the bids of Converge and PLDT for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated November 14, 2024;

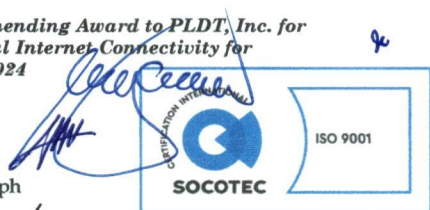

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last November 14, 2024, 03:30 P.M. on the bids of Converge and PLDT. The Committee made an arithmetical correction in the financial bid of Converge, the amount of bid as read was not the same as calculated. Meanwhile, the Committee made no arithmetical correction in the financial bid of PLDT, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Converge to be "non-compliant" of Item No. 2 for the reason: *The bidder's offer is not Cable TV and the 1 Cable Channel was not indicated in the submitted Brochure* while PLDT to be complying for Item No. 1 and declare the bid of PLDT as the Single Calculated Bid (SCB) at the amount of P1,646,400.00;

WHEREAS, the Committee informed Converge of their non-compliance for Item No. 2 in a letter dated November 14, 2024 and that they may submit a request for reconsideration *within three (3) calendar days upon receipt of the letter*;

WHEREAS, Converge did not submit any request for reconsideration;


WHEREAS, the Committee conducted an online post-qualification of PLDT at their main office in Ramon Cojuangco Building, Makati Avenue, Makati City, Metro Manila last November 22, 2024;

WHEREAS, the Committee convened and deliberated the results of their Post-Qualification on November 26, 2024. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of PLDT were genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *PLDT, Inc.* as the Single Calculated and Responsive Bid (SCRB) for Item No. 1 for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Additional Internet Connectivity for USTP-CDO Campus WIFI Services CY 2024*; and
- b) recommend the award of the contract in the total amount of **ONE MILLION SIX HUNDRED FORTY-SIX THOUSAND FOUR HUNDRED PESOS AND 00/100 (P1,646,400.00) ONLY.**
