# BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO NEW CENTURY BOOKS \& GEN. MDSE. IN THE AMOUNT OF P1,346,885.00, DECLARING PARTIAL FAILURE OF BIDDING AND RECOMMENDING RE-BIDDING OF THE REMAINING ITEMS FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-PANAON CAMPUS CY 2023 

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Procurement of the Supply and Delivery of Library Books for USTP-Panaon Campus CY 2023 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract ( ABC ) of THREE MILLION FOUR HUNDRED THOUSAND PESOS AND 00/100 (P3,400,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: New Century Books \& Gen. Mdse. (New Century) and Serv Enterprises;

WHEREAS, on the deadline for the submission of bids last November 20, 2023, 09:30 A.M., only New Century submitted its bid proposal. Serv Enterprises did not submit any bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;
WHEREAS, New Century was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of New Century;
WHEREAS, New Century made a bid of P1,350,785.00;
WHEREAS, the Committee considered the bid of New Century for evaluation;
WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated November 23, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last November 23, 2023, 01:30 P.M. on the bid of New Century. The Committee made an arithmetical correction in the financial bid of New Century, in which the amount of the bid as read was not the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of New Century to be complying and declared the bid of New Century as the Single Calculated Bid (SCB) at the amount of P1,346,885.00;

WHEREAS, the Committee conducted an online post-qualification of New Century Books at their main office in 36 Azalea Street, Sto. Nino de Maligaya Park, Brgy. 177, Caloocan City, Metro Manila last November 29, 2023;
