BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO MEGANTECH ENGINEERING CENTER OF THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING FOR MILK QUALITY AND SHELF LIFE THROUGH ULTRA-PASTEURIZATION AND SANITARY MONITORING SYSTEM FOR DAIRY AT USTP-CLAVERIA IN THE AMOUNT OF P5,000,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the Negotiated Procurement Under Two-Failed Biddings for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning for Milk Quality and Shelf life through Ultra-Pasteurization and Sanitary Monitoring System for Dairy at USTP-Claveria in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FIVE MILLION PESOS AND 00/100 (P5,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Megantech Engineering Center (Megantech);

WHEREAS, on the deadline for submission of bids last November 15, 2023, 02:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Megantech was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelope of Megantech;

WHEREAS, Megantech made a bid of P5,000,000.00;

WHEREAS, the Committee considered the bid of Megantech for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated November 22, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, on November 22, 2023, 02:00 P.M. on the bid of Megantech. The Committee made no arithmetical correction in the financial bid of Megantech, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Megantech to be complying and declared the bid of Megantech as the Single Calculated Bid (SCB) at the amount of P5,000,000.00:

WHEREAS, the Committee conducted an on-site post-qualification of Megantech at their main office in Purok 1A, Tablon, Cagayan de Oro City, Misamis Oriental last November 29, 2023;

WHEREAS, the Committee convened on December 07, 2023 and deliberated the results of their Post-Qualification. It was found that all the documents submitted by Mr. Salvador S. Templa of Megantech were genuine, authentic and responsive;
