

BAC RESOLUTION NO. 0968-2023

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO NEW CENTURY BOOKS & GEN. MDSE. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-OROQUIETA CAMPUS CY 2023 IN THE AMOUNT OF P2,088,683.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Library Books for USTP-Oroquieta Campus CY 2023* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION ONE HUNDRED THOUSAND PESOS AND 00/100 (P2,100,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: New Century Books & Gen. Mdse. (New Century);

WHEREAS, on the deadline for the submission of bids last December 07, 2023, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, New Century was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of New Century;

WHEREAS, New Century made a bid of P2,087,798.00;

WHEREAS, the Committee considered the bid of New Century for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated December 11, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last December 07, 2023, 11:00 A.M. on the bid of New Century. The Committee made an arithmetical correction in the financial bid of New Century, the amount of bid as read was not the same the same as calculated;

WHEREAS, in the Bid Form of New Century, there is discrepancies in Item Nos. 172, 197 and 250. As per Section 32.2.3 of the Revised IRR of R.A. 9184 that "In case of discrepancies between xxx (b) "Total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; and (c) stated total price and the actual sum of prices of component items, the latter shall prevail". Therefore, the unit price for Item Nos. 172, 197 and 250 are considered;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of New Century to be complying and declared the bid of New Century as the Single Calculated Bid (SCB) at the amount of P2,088,683.00;

WHEREAS, the Committee conducted an online post-qualification of New Century at their main office in 36 Azalea Street, Sto. Nino de Maligaya Park, Brgy. 177, Caloocan City, Metro Manila on December 14, 2023;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:
