BAC RESOLUTION DECLARING SINGLE CALCULATED BID (SCB) FOR THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT FOR USTP-VILLANUEVA

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-Villanueva in PhilGEPS*, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION FIVE HUNDRED EIGHTY ONE THOUSAND ONE HUNDRED PESOS AND 00/100 (ABC: P1,581,100.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Dataworld Computer Center (Dataworld);

WHEREAS, during the deadline and submission of bids on August 03, 2021, 02:00 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Dataworld was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Dataworld;

WHEREAS, Dataworld made a bid of P1,581,000.00;

WHEREAS, the Committee considered the bids of Dataworld for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on August 04, 2021, 02:00 P.M. on the bid of Dataworld. The Committee found no minor arithmetical correction in the financial bid of Dataworld. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated August 04, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Dataworld to be complying and declared Dataworld as the SCB at the amount of P1,581,000.00;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to declare the bid of Dataworld Computer Center as the Single Calculated Bid (SCB) for the *Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-Villanueva*.


