

BAC RESOLUTION NO. 133-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PRINCE TECHNOLOGIES CORPORATION OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INFORMATION SYSTEM SOFTWARE MAINTENANCE, ENHANCEMENT, AND WEBHOSTING IN THE AMOUNT OF P7,726,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Information System Software Maintenance, Enhancement, and Webhosting* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of SEVEN MILLION SEVEN HUNDRED TWENTY SIX THOUSAND AND 00/100 (ABC: P7,726,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Prince Technologies Corporation (Prince Technologies);

WHEREAS, during the deadline and submission of bids last March 14, 2022, 02:00 P.M., the same prospective bidder submitted its bid proposals;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Prince Technologies Corporation was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Prince Technologies;

WHEREAS, Prince Technologies made a bid of P7,726,000.00;

WHEREAS, the Committee considered the bid of Prince Technologies for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last March 15, 2022, 02:00 P.M. on the bid of Prince Technologies. The Committee found no minor arithmetical correction in the financial bid of Prince Technologies. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated March 15, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Prince Technologies to be complying and declared Prince Technologies as the Single Calculated Bid (SCB) at the amount of P7,726,000.00;

WHEREAS, the Committee conducted post-qualification of Prince Technologies last March 17, 2022;

WHEREAS, the Committee convened on March 24, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Ronny Boy Cambangay of Prince Technologies was genuine, authentic, and responsive;
