BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO DATAWORLD COMPUTER CENTER OF THE SECOND RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY AND INSTALLATION OF ICT EQUIPMENT FOR USTP-ALUBIJID CAMPUS CY 2025 IN THE AMOUNT OF P1,347,680.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Second Re-bidding for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment for USTP-Alubijid Campus CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (P1,500,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Masangkay Computer Center (Masangkay) and Dataworld Computer Center (Dataworld);

WHEREAS, on the deadline for submission of bids last June 25, 2025, 01:30 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Masangkay and Dataworld were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Masangkay and Dataworld;

WHEREAS, Masangkay made a bid of P1,494,400.00;

WHEREAS, Dataworld made a bid of P1,347,680.00;

WHEREAS, the Committee considered the bids of Masangkay and Dataworld for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated July 02, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last July 02, 2025, 02:00 P.M. on the bids of Masangkay and Dataworld. The Committee made no arithmetical correction in the financial bids of Masangkay and Dataworld, the amount of bids as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Masangkay and Dataworld to be complying and declare the bid of Dataworld as the Lowest Calculated Bid (LCB) at the amount of P1,347,680.00;

- b) recommend the award of the contract in the total amount of **ONE MILLION THREE HUNDRED FORTY-SEVEN THOUSAND SIX HUNDRED EIGHTY PESOS AND 00/100 (P1,347,680.00) ONLY.**


