BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO RAKSO COMPUTER TECHNOLOGY, INC. OF THE THIRD RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF EDUCATIONAL OFFICE LICENSE FOR DIGITAL TRANSFORMATION OFFICE CY 2025 IN THE AMOUNT OF P2,100,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Third Re-bidding for the Proposed Procurement of the Supply and Delivery of Educational Office License for Digital Transformation Office CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION ONE HUNDRED THOUSAND PESOS AND 00/100 (P2,100,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Rakso Computer Technology, Inc. (Rakso);

WHEREAS, on the deadline for submission of bids last June 03, 2025, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Rakso was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Rakso;

WHEREAS, Rakso made a bid of P2,100,000.00;

WHEREAS, the Committee considered the bid of Rakso for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated June 10, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last June 10, 2025, 03:00 P.M. on the bid of Rakso. The Committee made no arithmetical correction in the financial bid of Rakso, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Rakso to be complying and declared the bid of Rakso as the Single Calculated Bid (SCB) at the amount of P2,100,000.00;

WHEREAS, the Committee conducted an onsite post-qualification of Rakso at their main office Ricogen Bldg. 112, Aguirre St., Legaspi Village, Makati City, Metro Manila last June 19, 2025;


