BAC RESOLUTION NO. 707-2020

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO BWPSSI SECURITY AGENCY (BLACKWATER PHILIPPINES SECURITY SOLUTIONS), INC. OF THE PROPOSED PROCUREMENT OF SECURITY SERVICES FOR USTP-CDO IN THE AMOUNT OF P4.448,639.61

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement of Security Services for USTP-CDO in PhilGEPS*, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FIVE MILLION THREE HUNDRED THIRTY-FIVE THOUSAND NINE HUNDRED SIXTY-FOUR PESOS AND 77/100 (P5,335,964.77) ONLY;

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: JKB Republic Security Agency, Inc. (JKB Republic), Rover Eagle Security Agency (Rover Eagle) and BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. (BWPSSI);

WHEREAS, during the deadline and submission of bids last December 04, 2020, 10:00 A.M. the same prospective bidders submitted their bid proposal;

WHEREAS, the Committee then immediately opened the first envelopes of the following prospective bidders in chronological order;

WHEREAS, Rover Eagle and BWPSSI were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, JKB Republic was rated "failed" due to the following ground: Non-Submission of 2nd copy of the legal, technical and financial component of its bid;

WHEREAS, the Committee informed JKB Republic that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelopes of Rover Eagle and BWPSSI;

WHEREAS, Rover Eagle made a bid of P4,880,913.33;

WHEREAS, BWPSSI made a bid of P4,448,637.84;

WHEREAS, the Committee considered the bids of Rover Eagle and BWPSSI for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 07, 2020, 10:00 A.M. on the bid of Rover Eagle and BWPSSI. The Committee found minor arithmetical corrections in the financial bids of Rover Eagle and BWPSSI. The amount of bid as read was not the same as calculated;

WHEREAS, the Committee, assisted by the TWG, made the following findings for Rover Eagle: (a) fail to comply with labor standards, specifically on the computation on SSS Premium effective for the year 2021 per R.A. 11199 – Social Act of 2018. Therefore, Rover Eagle Security Agency is non-compliant;

BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending Award to BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. of the Proposed Procurement of Security Services for USTP CDO in the Amount of P4,444,639.61

WHEREAS, Rover Eagle submitted a letter-request for reconsideration and December 10, 2020 and received December 11, 2020. The Committee considered and granted the request of Rover Eagle in a letter dated December 11, 2020;

WHEREAS, the Committee continued the evaluation last December 14, 2020, and with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Rover Eagle and BWPSSI to be complying;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 07 & 14, 2020;

WHEREAS, the BWPSSI declared as the LCB at the amount of P4,448,639.61;

WHEREAS, the Committee conducted post-qualification of BWPSSI on December 15, 2020;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Atty. Alejandro Jose C. Pallugna of BWPSSI was genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. as Lowest Calculated and Responsive Bid (LCRB) for the Proposed Procurement of Security Services for USTP-CDO; and
- b) recommend the award of the contract in the total amount of FOUR MILLION FOUR HUNDRED FORTY EIGHT THOUSAND SIX HUNDRED THIRTY NINE PESOS AND 61/100 (P4,448,639.61) ONLY.
