



BAC RESOLUTION NO. 153-2021

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PRINCE TECHNOLOGIES CORPORATION OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF CLOUD HOSTING FOR USTEP AT AMAZON WEB SERVICES IN THE AMOUNT OF P2,988,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply and Delivery of Cloud Hosting for USTeP at Amazon Web Services* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND PESOS AND 00/100 (P2,988,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Prince Technologies Corporation (Prince Technologies) and SVI Technologies, Inc. (SVI Technologies);

WHEREAS, during the deadline and submission of bids last April 26, 2021, 10:00 A.M., only Prince Technologies submitted its bid proposal. SVI Technologies did not submit any bid proposal;

WHEREAS, the Committee immediately opened the first envelope of the lone bidder;

WHEREAS, Prince Technologies was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Prince Technologies;

WHEREAS, Prince Technologies made a bid of P2,988,000.00;

WHEREAS, the Committee considered the bids of Prince Technologies for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last April 27, 2021, 10:00 A.M. on the bid of Prince Technologies. The Committee found no minor arithmetical correction in the financial bid of Prince Technologies. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated April 27, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Prince Technologies to be complying and declared Prince Technologies as the Single Calculated Bid at the amount of P2,988,000.00;

WHEREAS, the Committee conducted post-qualification of Prince Technologies on April 29, 2021;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Rei Ruzzel Intud of Prince Technologies was genuine, authentic, and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:
