## BAC RESOLUTION NO. 558-2022

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BIDS (LCRB) AND RECOMMENDING AWARD TO SMART COMMUNICATIONS, INC. FOR ITEM NO. 1, GLOBE TELECOM, INC. FOR ITEM NO. 2 AND INNOVE COMMUNICATIONS, INC. FOR ITEM NO. 3 OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY FOR LOT 1 AND SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING FOR LOT 2 OF DATA AND INTERNET CONNECTIVITY FOR USTP-OROQUIETA CAMPUS

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement for the Supply and Delivery for Lot 1 and Supply, Delivery, Installation and Commissioning for Lot 2 of Data and Internet Connectivity for USTP-Oroquieta Campus in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FOUR MILLION EIGHT HUNDRED FIFTY-ONE THOUSAND PESOS AND 00/100 (P4,851,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, four (4) prospective bidders acquired the bidding documents, namely: Smart Communications, Inc. (Smart), PLDT, Inc. (PLDT), Globe Telecom, Inc. (Globe) and Innove Communications, Inc. (Innove);

**WHEREAS**, during the deadline and submission of bids last June 06, 2022, 10:00 A.M., the same prospective bidder submitted their bid proposals;

**WHEREAS**, the Committee then immediately opened the first envelope of the following prospective bidders in chronological order;

**WHEREAS**, Globe, Innove, Smart and PLDT were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Globe, Innove, Smart and PLDT;

WHEREAS, Globe made a bid of P1,095,300.00 for Item No. 2;

WHEREAS, Innove made a bid of P661,980.00 for Item No. 3;

WHEREAS, Smart made a bid of P2,555,700.00 for Item No. 1;

WHEREAS, PLDT made a bid of P1,196,160.00 for Item No. 3;

WHEREAS, the Committee considered the bids of Globe, Innove, Smart and PLDT for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on June 07, 2022, 10:00 A.M. on the bid of Globe, Innove, Smart and PLDT. The Committee found no arithmetical correction in the financial bids of Globe, Innove, Smart and PLDT. The amount of bid as read were the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 07, 2022

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Globe, Innove, Smart and PLDT to be complying;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on June 10, 2022. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of Smart and Mr. Jerome John S. Selim of Globe and Innove were genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

- a) declare the bids of Smart Communications, Inc. for Item No. 1, Globe Telecom, Inc. for Item No. 2 and Innove Communications, Inc. for Item No. 3 as the Lowest Calculated and Responsive Bids (LCRB) of the Proposed Procurement for the Supply and Delivery for Lot 1 and Supply, Delivery, Installation and Commissioning for Lot 2 of Data and Internet Connectivity for USTP-Oroquieta Campus;
- b) recommend the award of the contract to Smart Communications, Inc. for Item No.1 in the total amount of TWO MILLION FIVE HUNDRED FIFTY-FIVE THOUSAND SEVEN HUNDRED PESOS AND 00/100 (P2,555,700.00) ONLY; and
- c) recommend the award of the contract to Globe Telecom, Inc. for Item No. 2 in the total amount of ONE MILLION NINETY-FIVE THOUSAND THREE HUNDRED PESOS AND 00/100 (P1,095,300.00) ONLY.
- d) recommend the award of the contract to Innove Communications, Inc. for Item No. 3 in the total amount of SIX HUNDRED SIXTY-ONE THOUSAND NINE HUNDRED EIGHTY PESOS AND 00/100 (P661,980.00) ONLY.
