## **BAC RESOLUTION NO. 728-2020**

### **BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PRINCE TECHNOLOGIES CORPORATION OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SUPPLY, PROCUREMENT AND ASSET MANAGEMENT SYSTEMS FOR USTP - CDO IN THE AMOUNT OF P6,000,000.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Supply, Procurement and Asset Management Systems for USTP – CDO* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of SIX MILLION PESOS AND 00/100 (P6,000,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Prince Technologies Corporation (Prince Tech);

**WHEREAS**, during the deadline and submission of bids last December 16, 2020, 02:00 P.M., the same prospective bidder submitted its bid proposal;

**WHEREAS**, the Committee then immediately opened the first envelope of the lone bidder;

**WHEREAS**, Prince Tech was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of Prince Tech;

**WHEREAS**, Prince Tech made a bid of P6,000,000.00;

**WHEREAS**, the Committee considered the bids of Prince Tech for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 17, 2020, 02:00 P.M. on the bid of Prince Tech. The Committee found no arithmetical correction in the financial bid of Prince Tech. The amount of bid as read was the same as calculated;

**WHEREAS**, the Technical Representative and TWG submitted a Technical Report dated December 17, 2020;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Prince Tech to be complying and declared Prince Tech as the Single Calculated Bid (SCB) at the amount of P6,000,000.00;

**WHEREAS**, the Committee conducted post-qualification of Prince Tech on December 18, 2020;

**WHEREAS**, the Committee convened on and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Rei Ruzzel Intud of Prince Tech were genuine, authentic, and responsive;

**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:



- b) recommend the award of the contract in the total amount of **SIX MILLION PESOS AND 00/100 (P6,000,000.00) ONLY.**




