BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PLDT, INC. OF THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INTERNET CONNECTIVITY FOR USTP-PANAON CAMPUS IN THE AMOUNT OF P1,000,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Internet Connectivity for USTP-Panaon Campus in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION PESOS AND 00/100 (P1,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: PLDT, Inc. (PLDT);

WHEREAS, during the deadline and submission of bids last July 18, 2022, 1:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, PLDT was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of PLDT;

WHEREAS, PLDT made a bid of P1,000,000.00;

WHEREAS, the Committee considered the bid of PLDT for evaluation;

WHEREAS, The Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last July 19, 2022, 02:00 P.M. on the bid of PLDT. The Committee found no arithmetical correction in the financial bid of PLDT. The amount of bid as read was the same as calculated;

WHEREAS, The Technical Representative and TWG submitted a Technical Report dated July 19, 2022;

WHEREAS, The Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of PLDT to be complying and declared PLDT as the Single Calculated Bid (SCB) at the amount of P1,000,000.00;

WHEREAS, the Committee conducted post-qualification of PLDT on July 21, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of PLDT was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

a) declare the bid of PLDT, Inc. as the Single Lowest Calculated and Responsive Bid (SCRB) of the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Internet Connectivity for USTP-Panaon Campus;
