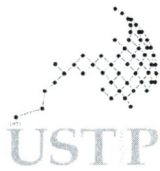

BAC RESOLUTION NO. 167-2022

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BIDS (LCRB) AND RECOMMENDING AWARD TO GLOBE TELECOM, INC. FOR ITEM NO. 1 AND SMART COMMUNICATIONS, INC. FOR ITEM NO. 2 OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF E-LOAD IN SUPPORT TO FLEXIBLE LEARNING PROGRAM

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply and Delivery of E-Load in Support to Flexible Learning Program* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FOUR MILLION EIGHT HUNDRED THOUSAND PESOS AND 00/100 (P4,800,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Smart Communications, Inc. (Smart) and Globe Telecom, Inc. (Globe);

WHEREAS, during the deadline and submission of bids last March 21, 2022, 10:00 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee then immediately opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Smart and Globe were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of Smart and Globe;

WHEREAS, Smart made a bid of P1,200,000.00 for Item No. 2;

WHEREAS, Globe made a bid of P3,600,000.00 for Item No. 1;

WHEREAS, the Committee considered the bids of Smart and Globe for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last March 22, 2022, 02:00 P.M. on the bids of Smart and Globe. The Committee found no minor arithmetical correction in the financial bids of Smart and Globe. The amounts of bids as read were the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated March 22, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Smart and Globe to be complying;

WHEREAS, Smart and Globe are declared as the LCB at the amount of P1,200,000.00 for Item No. 2 and P3,600,000.00 for Item No. 1, respectively;

WHEREAS, the Committee conducted post-qualification of Smart and Globe on March 28, 2022;

WHEREAS, the Committee convened on March 29, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of Smart and Mr. Jerome John S. Selim of Globe were genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bids of *Globe Telecom, Inc. for Item No. 1 and Smart Communications, Inc. for Item No. 2* as the Lowest Calculated and Responsive Bids (LCRB) of the *Proposed Procurement for the Supply and Delivery of E-Load in Support to Flexible Learning Program*;
- b) recommend the award of the contract to *Globe Telecom, Inc. for Item No. 1* in the total amount of **THREE MILLION SIX HUNDRED THOUSAND PESOS AND 00/100 (P3,600,000.00) ONLY**; and
- c) recommend the award of the contract to *Smart Communications, Inc. for Item No. 2* in the total amount of **ONE MILLION TWO HUNDRED THOUSAND PESOS AND 00/100 (P1,200,000.00) ONLY**.
