BAC RESOLUTION NO. 386-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO MASANGKAY COMPUTER CENTER OF THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT FOR USTP-CDO FY 2022 IN THE AMOUNT OF P975,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-CDO FY 2022* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION PESOS AND 00/100 (P1,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Hawk Rescue Equipment and General Merchandise (Hawk Rescue) and Masangkay Computer Center (Masangkay);

WHEREAS, during the deadline and submission of bids last May 05, 2022, 02:00 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee then immediately opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Masangkay was rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, Hawk Rescue was rated "failed" due to the following grounds: *Suspended validity of the Certificate of PhilGEPS Registration (Platinum Membership) submitted by the bidder for its failure to update the Certificate with the current and updated Mayor's Permit and Non submission of Additional Requirements to support the bidder's conformity with Technical Specifications;*

WHEREAS, the Committee informed Hawk Rescue that they may submit a motion for reconsideration within *three (3) calendar days;*

WHEREAS, the Committee then opened the second envelope of Masangkay;

WHEREAS, Masangkay made a bid of P975,000.00;

WHEREAS, the Committee considered the bid of Masangkay for evaluation;

WHEREAS, Hawk Rescue did not submit any motion for reconsideration;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last May 10, 2022, 02:00 P.M. on the bid of Masangkay. The Committee found no minor arithmetical correction in the financial bid of Masangkay. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated May 10, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Masangkay to be complying and declared Masangkay as the Single Calculated Bid (SCB) at the amount of P975,000.00;

WHEREAS, the Committee conducted post-qualification of Masangkay on May 13, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Wai Shing Peter W. Ko of Masangkay was genuine, authentic, and responsive;

WHEREAS, pursuant to the Revised IRR of R.A. 9184, following completion of the negotiations, the Committee requested the supplier in the proceedings to submit within *three (3) calendar days* upon receipt of the letter-request dated May 13, 2022 a *best offer* based on the final technical and financial requirements;

WHEREAS, Masangkay submitted their *best offer* in a form of accomplished financial bid form in the amount of P975,000.00 on May 16, 2022;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Masangkay Computer Center* as Single Calculated and Responsive Bid (SCRB) for the *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-CDO FY 2022*; and
- b) recommend the award of the contract in the total amount of **NINE HUNDRED SEVENTY-FIVE THOUSAND PESOS AND 00/100 (P975,000.00) ONLY**.


