BAC RESOLUTION NO. 389-2022

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BIDS (LCRB) AND RECOMMENDING AWARD TO FAST AUTOWORLD PHILIPPINES CORPORATION FOR ITEM NO. 1 AND AUTOCENTRAL INCORPORATED FOR ITEM NO. 2 OF THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLES FOR USTP-JASAAN AND USTP-CDO

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of Various Motor Vehicles for USTP-Jasaan and USTP-CDO* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FIFTY THOUSAND PESOS AND 00/100 (P2,050,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Autocentral Incorporated (Autocentral) and Fast Autoworld Philippines Corporation (Fast Autoworld);

WHEREAS, during the deadline and submission of bids last May 10, 2022, 10:00 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee then immediately opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Fast Autoworld and Autocentral were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of Fast Autoworld and Autocentral;

WHEREAS, Fast Autoworld made a bid of P1,099,500.00 for Item No. 1;

WHEREAS, Autocentral made a bid of P950,000.00 for Item No. 2;

WHEREAS, the Committee considered the bids of Fast Autoworld and Autocentral for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last May 11, 2022, 10:00 A.M. on the bids of Fast Autoworld and Autocentral. The Committee found no minor arithmetical correction in the financial bids of Fast Autoworld and Autocentral. The amounts of bids as read were the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated May 11, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Fast Autoworld and Autocentral to be complying;

WHEREAS, Fast Autoworld and Autocentral are declared as the LCBs at the amount of P1,099,500.00 for Item No. 1 and P950,000.00 for Item No. 2, respectively;

WHEREAS, the Committee conducted post-qualification of Fast Autoworld and Autocentral on May 13, 2022;

WHEREAS, the Committee convened on May 17, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Ms. Rhoda P. Tibayan of Fast Autoworld and Ms. Noemi S. Aranas of Autocentral were genuine, authentic, and responsive;

WHEREAS, pursuant to the Revised IRR of R.A. 9184, following completion of the negotiations, the Committee requested the suppliers in the proceedings to submit within *three (3) calendar days* upon receipt of the letter-requests dated May 17, 2022 a *best offer* based on the final technical and financial requirements;


WHEREAS, Fast Autoworld submitted their *best offer* for Item No. 1 in a form of accomplished financial bid form in the amount of P1,099,500.00 on May 18, 2022;


WHEREAS, Autocentral submitted their *best offer* for Item No. 2 in a form of accomplished financial bid form in the amount of P950,000.00 on May 18, 2022;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:


- a) declare the bids of *Fast Autoworld Philippines Corporation for Item No. 1 and Autocentral Incorporated for Item No. 2* as the Lowest Calculated and Responsive Bids (LCRB) of the *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of Various Motor Vehicles for USTP-Jasaan and USTP-CDO*;
- b) recommend the award of the contract to *Fast Autoworld Philippines Corporation for Item No. 1* in the total amount of **ONE MILLION NINETY-NINE THOUSAND FIVE HUNDRED PESOS AND 00/100 (P1,099,500.00) ONLY**; and
- c) recommend the award of the contract to *Autocentral Incorporated for Item No. 2* in the total amount of **NINE HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P950,000.00) ONLY**.
