BAC RESOLUTION NO. 584-2021

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PARASAT CABLE TV, INC. OF THE NEGOTIATED PROCUREMENT UNDER TWO FAILED BIDDINGS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INTERNET CONNECTIVITY TO SUPPORT FLEXIBLE LEARNING PROGRAM IN THE AMOUNT OF P1,200,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Negotiated Procurement Under Two Failed Biddings of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Internet Connectivity to Support Flexible Learning Program in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED THOUSAND PESOS AND 00/100 (ABC: P1,200,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Parasat Cable Tv, Inc. (Parasat);

WHEREAS, during the deadline and submission of bids on September 08, 2021, 02:00 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Parasat was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Parasat;

WHEREAS, Parasat made a bid of P1,200,000.00;

WHEREAS, the Committee considered the bid of Parasat for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on September 09, 2021, 02:00 P.M. on the bid of Parasat. The Committee found no arithmetical correction in the financial bid of Parasat. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated September 09, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Parasat to be complying and declared Parasat as the SCB at the amount of P1,200,000.00;

WHEREAS, the Committee conducted post-qualification of Parasat on September 15, 2021;

WHEREAS, during post-qualification, it was found that Parasat's computation of NFCC was incorrect. The Bidder's NFCC computation was not based on its Audited Financial Statements. The verified computation of NFCC done by BAC is insufficient at only -P1,268,457,185.00. As part of negotiation,

the Committee allowed Parasat to submit a Credit Line Certificate from a Universal or Commercial Bank, in lieu of its NFCC computation. Parasat was able to submit Credit Line Certificate from Asia United Bank, a Universal Bank;

WHEREAS, Committee convened and deliberated the results of their Post Qualification on September 30, 2021. It was found that all the documents submitted by Engr. Pocholo R. Trinidad of Parasat was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

- a) recommend for approval the extended period of post-qualification activities, that is, from September 15, 2021 to September 30, 2021 as per Section 13.7 of the Revised IRR of R.A. No. 9184;
- b) declare the bid of Parasat Cable Tv, Inc. as Single Calculated and Responsive Bid (SCRB) for the Negotiated Procurement Under Two Failed Biddings of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Internet Connectivity to Support Flexible Learning Program; and

c) recommend the award of the contract in the total amount of ONE MILLION TWO HUNDRED THOUSAND PESOS AND 00/100 (P1,200,000.00) ONLY.
