BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO DOUBLE DRAGON SECURITY FORCES AGENCY, INC. OF THE PROPOSED PROCUREMENT OF SECURITY SERVICES FOR USTP-OROQUIETA CAMPUS IN THE AMOUNT OF P1,214,803.84

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement of Security Services for USTP-Oroquieta Campus in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED NINETY NINE THOUSAND THREE HUNDRED SEVENTY-SEVEN PESOS AND 67/100 (P1,299,377.67) ONLY;*

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Double Dragon Security Forces Agency, Inc. (Double Dragon);

WHEREAS, during the deadline and submission of bids on October 04, 2021, 02:00 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Double Dragon was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Double Dragon;

WHEREAS, Double Dragon made a bid of P1,299,248.40;

WHEREAS, the Committee considered the bid of Double Dragon for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Provisional Member, Technical Representative, on October 05, 2021, 10:00 A.M. on the bid of Double Dragon. The Committee found minor arithmetical correction in the financial bid of Double Dragon. The amount of bid as read was not the same as calculated:

WHEREAS, the Technical Representative submitted a Technical Report dated October 05, 2021;

WHEREAS, the Committee, with the assistance of the Technical Representative, after scrutiny, careful evaluation and deliberation, found the bid of Double Dragon to be complying and declared Double Dragon as the Single Calculated Bid (SCB) at the amount of P1,214,803.84;

WHEREAS, the Committee conducted post-qualification of Double Dragon Security on October 07, 2021;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Atty. Marlo C. Bacoro of Double Dragon was genuine, authentic, and responsive;
