**BAC RESOLUTION NO. 855-2021**

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO WOMAN FINE CLOTHING, INC. OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF P.E. UNIFORM FOR USTP-CDO IN THE AMOUNT OF P664,875.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement for the Supply and Delivery of P.E. Uniform for USTP-CDO* in PhilGEPs, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION FOUR HUNDRED FORTY NINE THOUSAND FIVE HUNDRED PESOS AND 00/100 (P1,449,500.00) ONLY;

**WHEREAS**, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: ABC Garment Solutions (ABC), Woman Fine Clothing, Inc. (WFC), and Zashen Fashion (Zashen);

**WHEREAS**, during the deadline and submission of bids last December 01, 2021, 02:00 P.M., the same prospective bidders submitted their bid proposals;

**WHEREAS**, the Committee opened the first envelopes of the prospective bidders in chronological order;

**WHEREAS**, WFC, ABC and Zashen were rated "passed" in the preliminary examination of their legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of WFC, ABC and Zashen;

**WHEREAS**, WFC made a bid of P664,875.00;

**WHEREAS**, ABC made a bid of P1,439,000.00;

**WHEREAS**, Zashen made a bid of P780,000.00;

**WHEREAS**, the Committee considered the bids of WFC, ABC and Zashen for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 02, 2021, 02:00 P.M. on the bid of WFC, ABC and Zashen. The Committee found no arithmetical correction in the financial bids of WFC, ABC and Zashen. The amount of bids as read were the same as calculated;

**WHEREAS**, the Technical Representative and TWG submitted a Technical Report dated December 02, 2021;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of WFC, ABC and Zashen to be complying and declared WFC as the Lowest Calculated Bid (LCB) at the amount of P664,875.00;

**WHEREAS**, the Committee conducted post-qualification of WFC on December 06, 2021;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Helen M. Marcellano of WFC was genuine, authentic, and responsive;


