BAC RESOLUTION NO. 872-2021

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO ROCE CONSTRUCTION AND SUPPLY FOR THE PROPOSED INTERIOR RENOVATION FOR CAREER CENTER IN THE AMOUNT OF P1,003,096.25

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Interior Renovation for Career Center in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION ONE HUNDRED EIGHTY-SEVEN THOUSAND THREE HUNDRED FIFTY PESOS AND 50/100 (P1,187,350.50) ONLY;

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: Grand Alvatec Construction Corp. (Grand Alvatec), Days Traders and Services (Davs Traders), and Roce Construction and Supply (Roce Construction);

WHEREAS, during the deadline and submission of bids last December 07, 2021, 10:00 A.M., only Davs Traders and Roce Construction submitted their bid proposals. Grand Alvatec did not submit any bid proposal;

WHEREAS, the Committee then opened the first envelope of the prospective bidders in chronological order;

WHEREAS. Days Traders and Roce Construction were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the BAC then immediately opened the second envelope of Davs Traders and Roce Construction;

WHEREAS, Davs Traders made a bid of P1,068,614.82;

WHEREAS, Roce Construction made a bid of P1,007,808.48;

WHEREAS, the Committee considered the bids of Davs Traders and Roce Construction for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on December 09, 2021, 02:00 P.M. on the bids of Davs Traders and Roce Construction. The Committee found minor arithmetical corrections in the financial bid of Roce Construction and Days Traders. The amount of bid as read were not the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 09, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, dareful evaluation and deliberation, found the bids of Davs Traders and Roce Construction to be complying;

WHEREAS, Roce Construction was declared as the Lowest Calculated Bid (LCB) with an amount of P1,003,096.25;

WHEREAS, the Committee conducted post-qualification of Roce Construction on December 13, 2021;

BAC Resolution Declaring Lowest Calculated and Responsive Bid (LCRB) and Recommending to the Board of Regents the Award to Roce Construction and Supply for the Proposed Interior Renovation for Career Center in the Amount of P1,003,096.25

WHERAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Guilmars R. Cepeda of Roce Construction was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

- a) declare the bid of Roce Construction and Supply as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Interior Renovation for Career Center; and
- b) recommend the award of the contract to the said bidder in the total amount of ONE MILLION THREE THOUSAND NINETY SIX PESOS AND 25/100 ONLY (P1,003,096.25);
