BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO NEWBITECH IT SOLUTIONS FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION, INTEGRATION AND COMMISSIONING OF HYPER-CONVERGED INFRASTRUCTURE SERVER ENHANCEMENT FOR DIGITAL TRANSFORMATION OFFICE CY 2025 IN THE AMOUNT OF P6,500,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation, Integration and Commissioning of Hyper-Converged Infrastructure Server Enhancement for Digital Transformation Office CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of SIX MILLION FIVE HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P6,550,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Newbitech IT Solutions (Newbitech);

WHEREAS, on the deadline for submission of bids last March 10, 2025, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Newbitech was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Newbitech;

WHEREAS, Newbitech made a bid of P6,500,000.00;

WHEREAS, the Committee considered the bid of Newbitech for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated March 12, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last March 12, 2025, 02:00 P.M. on the bid of Newbitech. The Committee made no arithmetical correction in the financial bid of Newbitech, the amount of bid as read was the same as calculated;

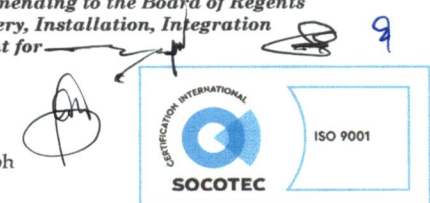
WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Newbitech to be complying and declared the bid of Newbitech as the Single Calculated Bid (SCB) at the amount of P6,500,000.00;

WHEREAS, the Committee conducted an online post-qualification of Newbitech at their main office in 249-A San Francisco Street, Purok Sto. Niño Buhangin, Davao City, Davao Del Sur on March 19, 2025;

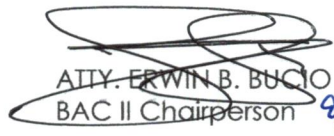
