BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO LIBER ENTERPRISE OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF PERPETUAL E-BOOKS SUBSCRIPTION FOR USTP-CDO CAMPUS CY 2024 IN THE AMOUNT OF P999,919.00

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Procurement of the Supply and Delivery of Perpetual E-Books Subscription for USTP-CDO Campus CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION PESOS AND 00/100 (P1,000,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Liber Enterprise (Liber);

**WHEREAS**, on the deadline for submission of bids last June 10, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, Liber was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelope of Liber;

WHEREAS, Liber made a bid of P999,919.00;

WHEREAS, the Committee considered the bid of Liber for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated June 11, 2024;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last June 11, 2024, 03:00 P.M. on the bid of Liber. The Committee made no arithmetical correction in the financial bid of Liber, the amount of bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Liber to be complying and declared the bid of Liber as the Single Calculated Bid (SCB) at the amount of P999,919.00;

**WHEREAS**, the Committee conducted an on-site post-qualification of Liber at their main office in 2F Door Seven O'Three Blda., Tionko Avenue, Davao City last June 14, 2024;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on June 21, 2024. It was found that all the documents submitted by Ms. Ervie L. Pelingon of Liber were genuine,
