BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO CARESYSTEM TECHNOLOGY SOLUTION CO., INC. OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ICT EQUIPMENT AND AIR-CONDITIONING UNITS FOR COLLEGE OF MEDICINE CY 2024 IN THE AMOUNT OF P621,215.00 FOR LOT 2

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of ICT Equipment and Air-Conditioning Units for College of Medicine CY 2024* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION EIGHT HUNDRED TWENTY-TWO THOUSAND PESOS AND 00/100 (P2,822,000.00) ONLY: LOT 1 – ICT Equipment (P1,800,000.00) & LOT 2 – Air-Conditioning Units (P1,022,000.00);

WHEREAS, in response to the said advertisement, five (5) prospective bidders acquired the bidding documents, namely: Holistic Educational Learning Innovation Exponents (Helix, Inc.), Inc. (HELIX), C & G Refrigeration and Airconditioning Service Center (C & G), COMFAC Corporation (COMFAC), Solidmark, Inc. (Solidmark) and Caresystem Technology Solution Co., Inc. (Caresystem);

WHEREAS, on the deadline for submission of bids last July 31, 2024, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, COMFAC, C & G, Caresystem and Solidmark were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, HELIX was rated "failed" in the preliminary examination of its legal, technical and financial documents due to the following ground: *There was no computation of the submitted Net Financial Contracting Capacity (NFCC)*;

WHEREAS, the Committee informed the representative of HELIX who was present during the bid opening that they may submit a request for reconsideration *within three (3) calendar days*;

WHEREAS, the Committee then opened the second envelopes of COMFAC, C & G, Caresystem and Solidmark;

WHEREAS, COMFAC made a bid of P1,300,000.00 for Lot 1;

WHEREAS, C & G made a bid of P640,828.20 for Lot 2;

WHEREAS, Caresystem made a bid of P621,215.00 for Lot 2;

WHEREAS, Solidmark made a bid of P1,587,688.00 (Lot 1 – P771,800.00 & Lot 2 – P815,888.00);

WHEREAS, the Committee considered the bids of COMFAC, C & G, Solidmark and Caresystem for evaluation;

WHEREAS, HELIX submitted a request for reconsideration in a letter dated and received August 01, 2024, which the Committee denied in a letter sent on August 08, 2024;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated August 07, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last August 07, 2024, 10:00 A.M. on the bids of COMFAC, C & G, Caresystem and Solidmark. The Committee made no arithmetical correction in the financial bids of COMFAC, C & G, Caresystem and Solidmark, the amount of bid as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of COMFAC to be non-complying for Lot 1, C & G and Caresystem to be complying for Lot 2 and Solidmark to be non-complying for Lot 1 and complying for Lot 2;

WHEREAS, the Committee informed COMFAC and Solidmark of their non-compliance for Lot 1 in letters dated August 07, 2024 and that they may submit a request for reconsideration *within three (3) calendar days* upon receipt of the letter;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Caresystem as the Lowest Calculated Bid (LCB) at the amount of P621,215.00 for Lot 2;

WHEREAS, COMFAC and Solidmark did not submit any request for reconsideration;


WHEREAS, the Committee conducted an on-site post-qualification of Caresystem at their branch office in Unit 4 G/F, Kiyosaki Bldg., Zone 9, Tablon Highway, Cagayan De Oro City on August 19, 2024;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Donna Mae I. Lucagbo of Caresystem was genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Caresystem Technology Solution Co., Inc.* as the Lowest Calculated and Responsive Bid (LCRB) for Lot 2 of the *Re-bidding for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of ICT Equipment and Air-Conditioning Units for College of Medicine CY 2024*; and
- b) recommend the award of the contract in the total amount of **SIX HUNDRED TWENTY-ONE THOUSAND TWO HUNDRED FIFTEEN PESOS AND 00/100 (P621,215.00) ONLY**.
