BAC RESOLUTION NO. 120-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO BELVIEW CO., INC. OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-CDO FY 2022 IN THE AMOUNT OF P2,450,044.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement for the Supply and Delivery of Library Books for USTP-CDO FY 2022* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (P2,500,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Belview Co., Inc. (Belview);

WHEREAS, during the deadline and submission of bids last March 08, 2022, 10:00 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Belview was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Belview;

WHEREAS, Belview made a bid of P2,450,044.00;

WHEREAS, the Committee considered the bid of Belview for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last March 09, 2022, 10:00 A.M. on the bid of Belview. The Committee found no minor arithmetical correction in the financial bid of Belview. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated March 09, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Belview to be complying and declared Belview as the Single Calculated Bid (SCB) at the amount of P2,450,044.00;

WHEREAS, the Committee conducted post-qualification of Belview on March 11, 2022;

WHEREAS, the Committee convened on March 15, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Ms. Leovenia S. Mariquina of Belview was genuine, authentic, and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:
