## BAC RESOLUTION NO. 339-2022

### **BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO FAST AUTOWORLD PHILIPPINES CORPORATION – MANDAUE CITY OF THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF VARIOUS MOTOR VEHICLES FOR USTP-SYSTEM IN THE AMOUNT OF P1,135,000.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of Various Motor Vehicles for USTP-System* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION ONE HUNDRED THIRTY-SIX THOUSAND PESOS AND 00/100 (P1,136,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Fast Autoworld Philippines Corporation – Mandaue City (Fast Autoworld);

**WHEREAS**, during the deadline and submission of bids last April 25, 2022, 02:00 P.M., the same prospective bidder submitted its bid proposal;

**WHEREAS**, the BAC then immediately opened the first envelope of the lone bidder;

**WHEREAS**, Fast Autoworld was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of Fast Autoworld;

**WHEREAS**, Fast Autoworld made a bid of P1,135,000.00;

**WHEREAS**, the Committee considered the bid of Fast Autoworld for evaluation;

**WHEREAS**, The Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last April 26, 2022, 02:00 P.M. on the bid of Fast Autoworld. The Committee found no arithmetical correction in the financial bids of Fast Autoworld. The amount of bid as read was the same as calculated.

**WHEREAS**, The Technical Representative and TWG submitted a Technical Report dated April 26, 2022.

**WHEREAS**, The Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Fast Autoworld to be complying and declared Fast Autoworld as the Single Calculated Bid (SCB) at the amount of P1,135,000.00;

**WHEREAS**, the Committee conducted post-qualification of Fast Autoworld last May 06, 2022;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Rhoda P. Tibayan of Fast Autoworld was genuine, authentic, and responsive;

**WHEREAS**, pursuant to the Revised IRR of R.A. 9184, following completion of the negotiations, the Committee requested the supplier in the proceedings to submit within *three (3) calendar days* upon receipt of the letter-request dated May 06, 2022, a *best offer* based on the final technical and financial requirements;

**WHEREAS**, Fast Autoworld submitted their *best offer* in a form of accomplished financial bid form in the amount of P1,135,000.00 on May 10, 2022;

**NOW, THEREFORE**, the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**, to:

- a) declare the bid of *Fast Autoworld Philippines Corporation – Mandaue City* as Single Calculated and Responsive Bid (SCRB) for the *Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply and Delivery of Various Motor Vehicles for USTP-System*; and
- b) recommend the award of the contract in the total amount of **ONE MILLION ONE HUNDRED THIRTY-FIVE THOUSAND PESOS AND 00/100 (P1,135,000.00)**;
