BAC RESOLUTION NO. 540-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO SCIGATE TECHNOLOGY CORP. OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LABORATORY EQUIPMENT FOR COLLEGE OF MEDICINE (2ND QUARTER FY 2022) IN THE AMOUNT OF P1,812,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement for the Supply and Delivery of Laboratory Equipment for College of Medicine (2nd Quarter FY 2022) in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FOUR HUNDRED THOUSAND PESOS AND 00/100 (P2,400,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: SciGate Technology, Corp. (SciGate).

WHEREAS, during the deadline and submission of bids last June 01, 2022, 02:00 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, SciGate was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of SciGate;

WHEREAS, SciGate made a bid of P1,812,000.00;

WHEREAS, the Committee considered the bid of SciGate for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last June 02, 2022, 02:00 P.M. on the bid of SciGate. The Committee found no minor arithmetical correction in the financial bid of SciGate. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 02, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of SciGate to be complying and declared SciGate as the Single Calculated Bid (SCB) at the amount of P1,812,000.00;

WHEREAS, the Committee conducted post-qualification of SciGate on June 06, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Francisco L. Go, Jr. of SciGate was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

a) declare the bid of SciGate Technology Corp. as Single Calculated and Responsive Bid (SCRB) for the Proposed Procurement for the Supply and Delivery of Laboratory Equipment for College of Medicine (2nd Quarter FY 2022); and
