BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO COLUMBIA COMPUTER CENTER, INC. OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ADDITIONAL LAPTOP COMPUTER FOR FACULTY IN SUPPORT TO FLEXIBLE LEARNING PROGRAM IN THE AMOUNT OF P3,960,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement for the Supply and Delivery of Additional Laptop Computer for Faculty in Support to Flexible Learning Program in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FOUR MILLION PESOS AND 00/100 (ABC: P4,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Columbia Computer Center, Inc. (Columbia);

WHEREAS, during the deadline and submission of bids last September 06, 2021, 10:00 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Columbia was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Columbia;

WHEREAS. Columbia made a bid of P3,960,000.00;

WHEREAS, the Committee considered the bid of Columbia for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last September 07, 2021, 10:00 A.M. on the bid of Columbia. The Committee found no arithmetical correction in the financial bid of Columbia. The amount of bid as read was the same as calculated:

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated September 07, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Columbia to be complying and declared Columbia as the SCB at the amount of P3,960,000.00;

WHEREAS, the Committee conducted post-qualification of Columbia on September 09, 2021;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Renante Elpa of Columbia was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,
