BAC RESOLUTION NO. 697-2021

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO MORTAR MASTERS AND CONCRETE BUILDERS FOR THE PROPOSED CONSTRUCTION OF THREE (3) STOREY UNIVERSITY HEALTH CENTER IN THE AMOUNT OF P12,299,263.06

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Construction of Three (3) Storey University Health Center* in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWELVE MILLION FIVE HUNDRED THIRTY-FOUR THOUSAND PESOS AND 00/100 (P12,534,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Mortar Masters and Concrete Builders (Mortar Masters);

WHEREAS, during the deadline and submission of bids last October 18, 2021, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Mortar Masters was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Mortar Masters;

WHEREAS, Mortar Masters made a bid of P12,299,243.57;

WHEREAS, the Committee considered the bid of Mortar Masters for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on October 20, 2021, 02:00 P.M. on the bids of Mortar Masters. The Committee found minor arithmetical corrections in the financial bids of Mortar Masters. The amount of bid as read was not the same as calculated;

WHEREAS, in the Bid Form of Mortar Masters, there are discrepancies in some items. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3 (b) "Total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; and (c), stated total price and the actual sum of prices of component items, the latter shall prevail". Therefore, the unit prices for some items are considered;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated October 20, 2021;

WHEREAS, the Committee, with the assistance of the Technical Representative, after scrutiny, careful evaluation and deliberation, found the bid of Mortar Masters to be complying;

WHEREAS, Mortar Masters was declared as the Single Calculated Bid (SCB) with an amount of P12,299,263.06;

WHEREAS, the Committee conducted post-qualification of Mortar Masters on October 27, 2021;

- b) recommend the award of the contract to the said bidder in the total amount of TWELVE MILLION TWO HUNDRED NINETY NINE THOUSAND TWO HUNDRED SIXTY THREE PESOS AND 06/100 ONLY (P12,299,263.06);


